On 19 July 2016 during a routine hazardous waste pick up, it was established that the Hazardous Waste registration had recently expired for the site and hence the installation code was out of date.

Natural Resources Wales (NRW) were immediately informed and so were the relevant waste carriers and the registration was renewed

Procedures have now been put in place to ensure that the registration is renewed in a timely manner next year.

Whilst a minor offence under the Hazardous Waste Regulations, due to the transparent communication from the operator and expedient manner that this issue was rectified no further action is being taken on this occasion. This does not preclude NRW from taking further action in the future if further offences under the aforementioned legislation occurs.
