On the 31st of May and 1st of June two complaints were received of emissions from the chimney at Knauf affecting a nearby property. Rust-like flakes were reported causing yellow and orange staining on vehicles and windows. Knauf investigated and agreed that the material had come from the main stack. The site had been on shut down over the previous days and a routine clean of the chimney had been carried out. It appears that a small amount of material had been loosened and not removed so it was carried out of the chimney when operations restarted.

This is the first occurrence of this type for many months since major work was carried out on the chimney in 2012. Procedures will be checked to try to prevent it happening in future.
