Work carried out during a planned shut down at Knauf Insulation resulted in emissions of "brown leaves" on start up. This led to a complaint from a neighbour after the material landed on her property. The impact was minor, however this is a repeat of previous incidents and demonstrates a failure to implement fully procedures that had been put in place to prevent the emissions, hence a breach of condition 1.1.1
