### Breaches of permit emission limits ( Condition 3.1.2):

Point G - (EP\_EX\_103) Testing carried out on 21st March with results reported 8th April, Results between 8.65mg/m<sup>3</sup> and 16.42mg/m<sup>3</sup> against limit of 10mg/m<sup>3</sup>. Previous testing had also shown high results and investigations have shown that the abatement is not adequate to control emissions since the increase in recycling wool within the plant. Improvement work is planned to resolve this and the score will be suspended.

Point C (EP\_EX\_108) Extractive test for VOC , results ranged from 17.5mg/m<sup>3</sup> to 127.5mg/m<sup>3</sup> against the limit of 50mg/m<sup>3</sup> on 4th April. As the site was not aware of the result until some time later it was difficult to determine the cause. However it was thought to be due to poor control of binder application. Work has since been carried out to improve this and VOC results from testing on 17/06/13 show emissions to be within the permitted limit.

Point A (EP\_EX\_102, 104, 105, 106, 107, 109, 110) - several breaches reported for CO between 07/04/13 and 21/05/13. Results ranged from 93.7mg/m<sup>3</sup> to >190mg/m<sup>3</sup> against a daily average limit of 80mg/m<sup>3</sup>. These were all thought to be due to the same recurring problem with a control mechanism on the burner system. The critical equipment was replaced once the problem was identified and there have been no further instances.

### Breach of reporting (Condition 4.2.3)

Point A (EP\_EX104, 105) Errors in data validation led to failure to report daily average CO breaches on 18/04 and 26/04.
