Permit breaches recorded:

Condition 1.1.1 - Problems with burner control system on furnace abatement led to elevated emissions of CO, NO_x and Particulate from Point A on the 28th of Feb and the 11th of March. Recorded as a breach of management / maintenance procedures.

Condition 3.1.2 - breach of limit for point G - the mainline cooling zone stack on 21/03/13 for particulate. This release point has an annual monitoring requirement, a previous sample taken in January was also above the permitted limit for particulate and investigations are ongoing into the reasons. The score has been suspended on this occasion.

Condition 3.5.1 - error in data validation methods led to a failure to report two incidents of elevated CO daily averages. High CO measured during purging with air has not been recorded as a breach of permitted limit.
