Introductory note

This introductory note does not form a part of the permit

The following notice is issued under regulation 17 of The Pollution Prevention and Control (England and Wales) Regulations 2000 (S.I.2000 No. 1973 (as amended) (the Regulations) to vary the conditions of a permit issued under the Regulations to operate an installation. The notice comprises schedule 1 containing conditions to be deleted, schedule 2 conditions to be amended and schedule 3 conditions to be added.

This variation introduces infrastructure and operational changes within the permitted installation. An additional mezzanine floor is to be located in the main process building. The purpose of this floor is to provide storage space for existing waste brought into site. The variation does not require any changes to the quantities of waste to be stored prior to treatment or off site disposal of hazardous waste. The application includes revised operational procedures to manage a two tiered waste storage area.

The addition of a new shredder unit (M70) that was introduced to the site following a notification has been included within this variation. The M70 shredder is the primary shredder utilised on site.

The Application

This application by the operator is a Regulation 17 variation dated 13/04/07 for the construction and operation of mezzanine floor (2-tier storage) and is a simple standard variation.

Insufficient technical information was supplied with the original application and a Schedule 7 notice was issued to request further technical detail.

The mezzanine floor storage area will provide additional storage capacity to the site. The variation does not apply or allow an increase in the permitted waste quantities.

Details of the construction, protection of current infrastructure and operational procedures have been provided as part of the application and the schedule 7 notice response.

The potential emissions from the process are detailed in the risk assessment that forms part of Part C of the original application (document C2.11b). There are no significant additional releases from the site as a result of the construction. The surface area for cleaning has increased and hence there would be a small increase in the amount of effluent sent to sewer. However, this is minimal in quantity and did not require a change to the sewer discharge limits.

The construction is within the current site boundary. The variation does not alter the current installation boundary.

The previous Reg. 16 notification for the new shredder unit has been included within the variation. We note that this notification was determined in a period beyond the 14 day period. Further details were requested from the operator that extended this timescale.




