The purpose of the site visit was for the new inspector to carry out a familiarisation visit and to get a general update from site.

A site walk around of the permitted area was carried out. The two CHPs were running during the visit. The gas to grid plant is currently being commissioned. This is likely to take approximately a further month. The Operator stated that once the Gas to Grid plant is fully operational the CHP plant will still run for more than 10% of the time in order to provide heat for the site.

Reminder that the Improvement Conditions within the latest variation are due by the end of June. Highlighted to the Operator that the recent variation includes additional reporting requirements to the previous permit.

It is hoped to upgrade the AD plant on site to an AAD, planning permission is currently being applied for.

The monitoring requirements of the permit were discussed. A further meeting to discuss this in more detail will take place in the next few months.
