Improvement Condition 1

The recent variation required the Operator to incorporate the Biomethane Injection Plant into the Accident Management Plan by the end of June 2015.

Improvement Condition 2

The recent variation required the Operator to update the Environment Management System to cover the Biomethane Injection Plan.

Updated copies of both of these documents have been submitted to Natural Resources Wales. These Improvement Conditions are therefore considered as complete.

However, please note the following comments / recommendations on these documents.

Emergency Procedures

1. The procedure makes reference to the Environment Agency, this should be changed to Natural Resources Wales.
2. It would be useful to include all relevant emergency phone numbers within this procedure.
3. Section 1.1 refers to the digestion plant. Are there any additional PPE requirements for the CHP / Biomethane Injection Plant?
4. There is no mention to calling NWFRS in section 1.2.2 although it talks about the potential for fire.

Environmental Management Plan

1. There is no mention of the reporting / notification requirements of the Environmental Permit within the document submitted. Is this covered elsewhere?

The details in both of these documents will be reviewed during future audits on site.
