Point A - (EX_116) Daily average CO emissions 114.88mg/m³ against limit of 80mg/m³. Reported by telephone at the time. Due to a burner trip on start up on the 27th Sept 2013. The emergency stack opened for 11 minutes resulting in high CO and emissions of particulate, SO_x, and NO_x. Emergency stack opening was also reported (EX_115).
