On 29/03/2019 we received a notification (Self Report 94929909, WIRS 1902001) from DCWW stating that the telemetry alarm had identified the CSO to be potentially spilling in dry weather conditions. Operational staff attended the site where they found a blockage at the mouth of the CSO. There was some rag build up within the sewer which was cleared. No major issues identified otherwise.

I later received an update from Sam Hampson stating that this was a spill due to a blockage on the flow control within the CSO. DCWW got up there as soon as they saw that the telemetry had spiked. A ball of rag had caught on the flow control which limits the downstream flows. Flows were very low in the CSO so the volume going out to the river was also low, it looks as though a lot of it was kept within the CSO chamber itself, once it had filled the chamber the waste was screened.

As the CSO discharged in dry weather conditions, it was in breach of section 4 of the permit -

The Discharge shall occur only when the rate of flow in the sewer at the combined sewage overflow exceeds 50 litres per second **due to rainfall and/or snow melt.**

DCWW also submitted a no impact claim form, however this was rejected as sewage entered the watercourse so we were unable to classify this as an event.
