Breach of condition 3.2.1 - control of fugitive emissions

A complaint was made about gritty dust on a car at a neighbouring property on the 23rd of Jan. Knauf investigated and accepted that the dust appeared to be fine material from their site. The hot waste had been emptied early in the morning of that day and the dust was likely to be from this activity. Procedures are in place to minimise dust releases and staff need to be reminded to follow these and ensure the water sprays are operating when material is removed from the hell hole.
