All monitoring was carried out as required by the permit and reports submitted on time.

3 instances of breach of the daily average CO limit on point A, the cupola emissions stack. - 86.14, 97.59 and 111.65mg/m³ against a limit of 80mg/m³. These were due to the oxidiser burner tripping out. This is an ongoing issue and investigations are being carried out to find the root cause. For the purposes of compliance, one Category 3 breach of Condition 3.2.1 has been recorded for these three events. (CCS no.216696)
