All monitoring was carried out as specified in the permit, and reports submitted on time.

Breaches were reported when first observed - Condition 3.1.2 emission limits to air:

Point A - Cupola stack, breach of CO daily average limit on four occasions - 04/11 (Ex_118), 29/11 (Ex_124), 04/12 (Ex_125), 06/12 (Ex_126) maximum reported 571.73mg/m³ on 04/12 against the limit of 80mg/m³. Work was carried out during the Christmas shutdown to repair the fault on the burner control mechanism.

Point C - Mainline forming stack, breach of limits during extractive monitoring on 24th Oct (Ex_121) - VOC -maximum reported 68.6mg/m³ against limit of 50mg/m³. Particulate matter 55.9mg/m³ against limit of 50mg/m³. Ammonia 51.1mg/m³ against limit of 50mg/m³. The point was re-sampled in December and all emissions were within the permitted limits.

All breaches combined to one Cat 3 breach for the purpose of compliance.

Point G - Cooling zone stack, breach of Particulate and Ammonia limits during extractive monitoring on 24th Oct. Improvements are planned for this abatement and the breaches will not contribute to the compliance score for this quarter.

Part B notifications are still outstanding for all events from 31/05/2013 onwards - Ex_112 to Ex_116.
