Assessment of monitoring reports and non-compliance events between April and June 2014

All monitoring was carried out as required by the permit and reports submitted on time.

Schedule 6 Part A notifications have been submitted for all events where the permit limits were breached, however the Part B follow up reports have not been submitted for event nos. 112 to 141 covering a period of over 12 months. These reports need to be submitted to demonstrate that the events have been investigated and to describe what action has been taken to prevent a recurrence. This failure to submit the reports has been recorded as a Category 4 breach of condition 4.3.2 of the permit.

Three breaches of the daily average CO emission limit have been reported for this period. These occurred on 09/04, 21/05 and 29/06. The three events have been recorded as one category 3 breach of permit condition 3.1.2.

A breach of the HCl emission limit for point A was reported following the routine extractive monitoring. This will be recorded with the annual monitoring report at the end of the year, however a Part B to explain the cause, as far as possible, will be required.

On 23 June a complaint was made by a neighbour about a fall out of grit from the site. No specific cause was found, but it was possibly due to the process being on hold for an extended time. This has been recorded as a category 3 breach of condition 3.2.1 and a site warning issued.
