### Quarterly and Six-monthly monitoring requirements


All monitoring was carried out as required. A single breach of permit has been recorded for the high daily average CO results from emission point A during the period. Work was carried out in October to replace a control mechanism on the incinerator which appears to have resolved the problem.

Form Air1a due in October was submitted late. A Cat4 permit breach was recorded for this.

The emission limit breach for Point G reported on a Part A in October will be recorded with the annual assessment when the reporting form is received.

Two complaints of dust on neighbouring properties were received in September. These were investigated by Knauf and explained as being due to vehicles having to use the Rectors Lane entrance to the site and causing dust. A single breach of permit condition 3.2.1 has been recorded for these events.
