Emissions monitoring for January to March 2015

All monitoring was carried out and reported as required.

Only one breach of permitted limits occurred during the quarter, a problem with the coke feed led to high SO₂ emissions on 19/02. Recorded as a Category 4 breach of condition 3.1.2

A complaint was made on 27/03 about droplets and particles falling on a neighbour's property. This was investigated and found to be emissions from the main stack; it was only a few days before the planned shutdown and cleaning of the internal stack lining so this should prevent a recurrence in the short term. This has been recorded as a Category 3 amenity breach of condition 3.1.2

A Schedule 6 notification was made on 19/03 when the emergency stack opened three times within a few hours. This was found to be due to an overpressure in the Enertex causing an explosion panel to blow. This then caused a high differential pressure across the Enertex which made the emergency cap open as a safety response.
