Emissions monitoring and reporting for April to June 2015

All monitoring was carried out as required during the quarter and reports submitted. There were no breaches of emission limits for the quarterly monitoring parameters.

Two Schedule 1 Part A notifications were made during the quarter:

05/06/15 (EX_148) HCl monitored for the annual return on 20/04 - the three results were all above the ELV. Results were 70mg/m³, 34.1mg/m³ and 41.4mg/m³ against the limit of 10mg/m³. This has not been recorded as a non-compliance on this form as it will be reported on the annual return and is a known issue that is undergoing investigation.

19/06/15 (EX_149) The emergency stack was open for 14 minutes when there was a problem on start up. This did not result in any complaints and as it is a safety measure it is not a breach of the permit conditions.
