Compliance monitoring for June to September 2015

All monitoring was carried out as required by the permit and reports submitted.

A Part A notification (Ex_153) was submitted for a minor breach of the SO₂ daily average limit from point A. The result was 1371mg/m³ against the limit of 1350. As this is within the 10% uncertainty associated with the measurement technique, no breach of permit has occurred.

The high CO results have been included in the compliance report for the inspection on 15/09, and all other emissions to air were within the emission limits for this quarter.

Emissions to surface water and sewer were monitored as required. There are no emission limits for these parameters.
