This report covers the quarter 4 and annual emissions monitoring for 2015

Emissions to air

All the monitoring was carried out as required and emission breaches notified under Schedule 5 Part A. Part B follow up notifications have been received for all 2015 emissions breaches.

A breach of the limit for HCl on point A was reported for the sampling carried out on 20/04/15, with results of the triplicate monitoring being 70mg/m³, 34.1mg/m³ and 41.4mg/m³ against a limit of 10mg/m³. Work is ongoing to find the source of the high HCl.

Breaches of the ammonia and particulate limits were reported for point G for sampling carried out on 7/10/15. Results were given as particulate – 11.59mg/m³, 16.43mg/m³ and 16.44mg/m³, and ammonia 13.6mg/m³ and 20mg/m³. This is an ongoing problem that is subject to an improvement condition to investigate improvements due for submission by 31/07/16.

A breach of the particulate limit on point C for the monitoring carried out on 5-6/10/15 was reported, results were 76.5mg/m³ and 118.5mg/m³ against the limit of 50mg/m³.

A single Category 3 non-compliance has been recorded for the emission limit breaches.

Emissions to water

The monitoring was carried out as required. There are no emission limits on discharges to water.
