Unannounced site inspection undertaken by Michael Edwards and Sally Wakeford of Natural Resources Wales. On arrival, site was closed, and gates were locked.

General Management (C1)

Under condition 1.1.4 The operator shall comply with the requirements of an approved competence scheme. A request to provide information on the current TCM was submitted in the previous Compliance Assessment Record, CAR_NRW0039468.

Mr Danter-Hill has confirmed that he is now the TCM for the site operations.

Records submission (G4)

Condition 4.2.2 states - Within one month of the end of each quarter, the operator shall submit to Natural Resources Wales using the form made available for the purpose, the information specified on the form relating to the site and the waste accepted and removed from it during the previous quarter.

It has been confirmed by the Waste Returns department that returns have been submitted for 2021. However, at present there is a backlog within the department and as such they have yet to be reviewed.
