### Compliance

#### 1. CCS3 - Condition 2.2.4 Fugitive emissions of substances to air

13 July 2017 loss of containment of 38 tonnes of LUWA Residues diluted with 25% water (non-flammable polymerised TAED species) from tank T083 to containment bund. No loss to the environment and the material was recovered and subsequently incinerated as normal on site as per established procedures. The material was at 50 C when discharged though no reports of vapours and no odour complaints have been received.

The investigation into this incident identified the root cause to be human error. The incinerator unit was shut down to replace the feed pump. Tank T083 was isolated and the drain line valve opened and nothing came out. On start up the drain line valve was left open and subsequently cleared resulting in the loss of containment. The valve was closed and a camlock end cap fitted.

The isolation sheets have been modified to identify the status of the valves in the system and the person responsible has been interviewed in line with procedures.

#### 2. CCS3 - Condition 2.2.2 Emissions to water, Table 2.2.5

20 August 2017 breach of suspended solids at emission point W1 of 305 vs 250 mg/l limit and 21 August of 283 mg/l, believed to be influenced by the presence of fungal hyphae. The installation of an automatic sampler will enable the taking of aliquots throughout the discharge to better understand the discharge profile and inform as to the optimal water treatment dosing regime.
