### Emergency vent operation due to ID fan trip

A number of incidents have occurred where the emergency vent has opened due to the ID fan tripping out. Two such incidents were reported in May 2013 since the last planned shutdown in April. No such incidents were reported in June but there have been eight such reported incidents in July 2013. The Operator has removed panelling to the ID fan and employed a fan for additional ventilation in an attempt to prevent thermal overload. It has been markedly warm throughout July. However, there have been some earlier incidents of this occurring, all be it less frequently. The Operator is advised to ensure the root cause of such incidents is appropriately identified so that measures can be put in place to prevent recurrence.

At this stage the additional and induced ventilation provided do not appear to be preventing recurrence. The Operator has commissioned an electrical contractor to look at the ID fan. The Operator is also advised to investigate other potential causes and likely pressures on the ID fan to ensure the cause is identified and prevention put in place.

### Notifications

The above emergency vent incidents have been notified without delay in accordance with Condition 5.1.1 of the Permit. However, written confirmation including reasons for operation of the emergency vent and the measures to prevent recurrence for incidents of the 9th and 11th of July have not yet been provided. The Operator is advised to provide these as soon as practicable following such an event as required by Permit Condition 5.1.2.4.

### Reporting

Permit Condition 4.1.2 requires monthly reporting of CEMs data and bottom ash within 28 days of the end of the reporting period. The last monthly data received was for March 2013. Reporting of monitoring data in accordance with Permit requirements was discussed. The Operator is aware of the requirements and has agreed to report data in accordance with Permit requirements.
