Monthly CEMs data for A1

All monthly data provided as required by Permit.

Permit breaches for period as follows:

- 23/08/14 10:30 – 10:59 SO₂ concentration of 440mg/m³ half hourly average to ELV of 200mg/m³ (**Permit Breach Emissions Air E1 - Emissions to air CCS = 3**) – Part A & B received 28/08/14 reported waste loaded at time was identified and liaison with producer advised. Waste loading stopped and following half hourly average within limits.

A1 Bi-annual Periodic sampling

- 12/11/14 Cadmium & Thallium concentration of 0.07mg/m³ was obtained in the bi-annual periodic monitoring against an ELV of 0.05mg/m³. **Part B investigation and re-test results still awaited. (Permit Breach Emissions Air E1 - Emissions to air CCS = 4).** This breach is only marginal.
