We wrote to you on 6 June 2022 asking you to send us more information before we could consider duly making your application. The response you submitted on 17 June 2022 and 1 July 2022 however was incomplete, and key information is still missing from your application. - Based on outcome of noise impact assessment above and if applicable provide a noise management plan in line with BAT requirements.
- Appropriate evidence of Technical Competency.
