4. Details of our assessment

This CAR is in relation to Q1 monitoring for 2022.

The operator sent an email on the 29th April 2022 advising that there would be a delay in the submission of the Q1 returns do to a number of internal factors.

The Q1 returns were received for air and water on the 13th May 2022, which is outside of the timeframes as set out in permit BK3638IF.

The return for water was a 'nil return' as the cooling system was not emptied in Q1.

All parameters were within the emission limit values as set out in the above permit.

Condition 4.2.3 states:

Within 28 days of the end of the reporting period the operator shall, unless otherwise agreed in writing by Natural Resources Wales, submit reports of the monitoring and assessment carried out in accordance with the conditions of this permit

Therefore NRW considers this as a CCS4 (C4) non compliance which has no potential environmental impact. However on this occasion NRW have suspended the score as the Operator highlighted there would be a delay in sending through the monitoring report and this was accepted as reasonable.
