OPRA Review

The OPRA review picked up some amendments required which bring the total OPRA score to 79 for the installation.

Annual Submissions

The annual reporting information was received 22/01/14.

Monitoring of emissions to air from A1, A2, A3, A5, and A6 has been undertaken on a quarterly basis throughout 2013 as required by the Permit.

E1 Emissions to Air - Condition 3.1.2 - CCS = 3 (ref 210773). Monitoring of A2 and A5 on the 02/09/13 showed concentrations of 8.25kg/hr and 3.57kg/hr VOCs respectively. This is in excess of the Permitted Emission Limit Value of 2kg/hr with a minor potential environmental impact. Re-testing of emissions on 22/10/13 showed them to be within emission limits at 1.127kg/hr and 0.021kg/hr respectively.

All other monitoring results demonstrate Permit compliance.

Performance parameters were provided as required by the Permit for water, energy, and waste.

Solvent usage data and some data on losses were provided, but no total solvent emissions as a % of solvent input was provided as required by the Permit and reporting forms. This is required to ensure compliance with the Solvent Emissions Directive. **The Operator is advised to ensure a solvent management plan is in place together with correct reporting so as to satisfy the requirements of the Directive and Permit.**

G4 - Reporting and Notifications Condition 4.2.1(b) CCS = 4. There is a requirement for a summary report of the previous year's progress against targets. This was not provided. **The Operator has an Environmental Management System accredited to ISO 14001 and should provide such a summary.** No environmental impact, this is just a reporting requirement.
