A Part A was received on 9 December 2016 in relation to an odour complaint made by NRW Officers on 26 October 2016.

Permit condition 3.4.1 requires that emissions from the operations *shall be free from odour at levels likely to cause annoyance outside of the site*. Odours were detected by NRW Officers on Shotwick Road, as well as on the industrial estate between your site and Iceland. Breach permit condition 3.4.1.

The cause of the complaint was reported to be as a result of a faulty switch on the scrubber at the resin plant. The switch has now been replaced (please confirm when this was done). The part A was not submitted within 24 hours of the Operator becoming aware of the problem with the faulty switch, breach permit condition 4.3.2.

The investigation is still on-going and therefore the part B has not yet been submitted. The Part B shall be submitted asap, if the investigation is not available by 30 January, please provide an update of the investigation to date.

EMS procedure DEE-PRO-027 Legal and IPPC Compliance briefly covers the notification requirements of the permit. The Operator shall review the current procedure to ensure it is robust enough to secure permit compliance by 30 January 2017. The Operator shall also ensure that all personnel on site with a responsibility to notify NRW under section 4.3 of the permit are aware of their responsibilities and are suitably trained, by 30 January 2017.

Daily odour checks are carried out at key locations on site. The daily check did not pick up the issue of odour related to the faulty switch the scrubber. The Operator shall review the current internal odour investigation procedure to ensure it is fit for purpose. This review shall include an assessment of the correct person / people (it would be useful to utilise two staff - a non plant operative to detect the odour, plant staff to identify the source if odour detected) to do the checks and the consideration of off site checks. This review shall be carried out and fed back to NRW by end February 2017.
