Monitoring Returns for 2014

Monthly S1 and efficacy tests have all been received for 2014 and show a pass.

Quarterly monitoring results for A1 & A2 have also been received.

A breach for A2 Holoflite total fungi 1668 cfu/m³ exceeding the 1000cfu/m³ ELV on the 08/07/14 was recorded and notified as required by the Permit. **Condition 3.1.2 Table S3.1 E1 Emissions to air CCS 3.** Following cleaning out flock from condenser, scrubber, and biofilters a re-test showed that the emission met the ELV on the 12/08/14.

Another breach for A2 Holoflite total fungi 1512 cfu/m³ exceeding the 1000cfu/m³ ELV on the 10/12/14 was recorded and notified as required by the Permit. **Condition 3.1.2 Table S3.1 E1 Emissions to air CCS 3.** A re-test on the 08/01/15 met the ELV with a concentration of 240 cfu/m³.

Annual production and performance parameters have been provided as required by the Permit. That for waste appears to show 2013 figures. **The Operator must confirm and submit waste tonnages for 2014 by the 06/03/15.**


Pollution inventory requires submission by 28/02/15.

Site Inspection 03/13/14

Maintenance on the HDU abatement and checks are conducted regularly. Flow gauges show a very low flow on the biobeds and the flow to the scrubber is checked and adjusted as required.

The scrubber liquor quality is not monitored and dosed. **It may be advisable to review this in light of some of the breaches noted above.**

Improvements to inspection and maintenance of the abatement have been made as a result of the breach of ELV at emission point A2.
