Quarterly Emissions to Air

Not all quarterly emissions results for A1 & A2 have been received as required by the Permit. The full analytical report was provided for July – September (Q3) but the Operator is reminded of the Permit requirements to report on form Air 1. The Q4 results can be provided following delayed monitoring agreed for January 2016. **G4 Reporting – Condition 4.2.3 of the Permit requires reporting within 28 days of the end of the reporting period which begins 01/01/06 every 12 months CCS = 4. The Operator must provide these forms as soon as delayed Q4 results are available.**

A breach for A2 Holoflite total fungi 2712 cfu/m3 exceeding the 1000cfu/m3 ELV on the 06/08/15 was notified as required by the Permit. **Condition 3.1.2 Table S3.1 E1 Emissions to air CCS 3.** Following cleaning out flock from condenser, scrubber, and biofilters a re-test showed that the emission met the ELV on the 11/09/15.

Monthly Emissions to Sewer & Monthly Efficacy Tests

Data of average daily flow to sewer and a summary of monthly efficacy tests was provided stating all have passed. These are required to be provided every 3 months within 28 days of the end of the reporting period. Some were submitted late **G4 Reporting – Condition 4.2.3 CCS = 4.**
