4. Details of our assessment

On the 17 February 2022 we received a pollution report of discoloured runoff escaping from Capestone Farm's manure heaps and tracking down an adjacent valley before entering a watercourse. Capestone were notified on the day, and it was confirmed that a breach in a bund surrounding a manure heap had occurred during the recent storms (Storm Eunice) which allowed manure effluent to escape to land. The earth bund was repaired the same day to stop the issue. Environment Officer Chris Roscoe then attended the Capestone site on the 23 February and met with Viran Abeysena and Rob Cumine from the facility and discussed the issue before examining the manure heaps.

At the manure heaps (SM 85976 09569) evidence showed that liquid runoff had breached an earth bund situated downhill on the downhill side of the heaps. Between the newly repaired earth bund and the heap was a significant pool of manure runoff. The effluent was tracked down the steep sided valley and down to the stream. Along this length the flow of the effluent reduced down to a small trickle at the watercourse. No discolouration, signs of contamination, or sewage fungus growth was seen in the water. This constituted an unauthorised emission point from the site, in breach of the site's permit (QP3739UM).

As the immediate discharge had been stopped, discussion was had regarding the long-term control of this risk, and it was suggested that the operator review current agricultural regulations to satisfy themselves that they maintain their compliance. It was also agreed by Viran that there would be an increase in the number of checks of the bunding from the current once a month frequency to weekly checks, and that pooling effluent (as was seen during the visit) will be actively managed through pumping and appropriate disposal.

We will seek to recover our investigation costs incurred on the 23 February 2022 under Section 161, Water Resources Act 1991 (as amended by Environment Act). We will forward an invoice in due course detailing the costs.
