Comments

1. Scald De-Feather Odour Abatement - Odour Sampling and & Modelling Report

Thank you for providing the above report following the installation and commissioning of the scald de-feather scrubber. The report shows that the scrubber is reducing odour below $1000 \text{ OU}_E/\text{m}^3$ (averaged across 3 samples) at the point of release indicating that the scrubber meets the design specification provided by Parsons Engineering / VION at the BAT review stage.

Emissions from the scrubber stack (as measured) are predicted to give rise to ground level concentrations not exceeding $1.5 \text{ OU}_E/\text{m}^3$ outside the site boundary (note the $1.5 \text{ OU}_E/\text{m}^3$ isopleth only just exceeds the site perimeter boundary). Therefore scald defeather odour is now unlikely to cause annoyance outside the site boundary, particularly in residential areas which are generally some distance from the site.

Natural Resources Wales has not substantiated any scald odour outside the site boundary since the the scrubber was commissioned, all evidence suggests that the scrubber has been very successful in minimising scald de-feather odour.

During the inspection the 'Sandycroft Scald Odour Abatement Operating Procedure' was viewed that covers the operation of the scrubber, particularly the required start up procedure. This is supplemented by daily checks on the scrubber system. Engineering and Effluent Plant operatives have received procedural training and sign off. During the inspection the scrubber was viewed and was operating normally. No scald odour was noted onsite whatsoever.

2. Routine Monitoring Returns

Routine quarterly / annual returns as required by permit conditions 4.1.2 and 4.1.3 have not been received by end January 2014 - this breach of permit attracts a CCS score of 4. Please submit the returns by 14/02/14.
