Emissions from the activities shall be free from odour at levels likely to cause pollution outside the site, as perceived by an authorised officer of the Environment Agency, unless the operator has used appropriate measures, including, but not limited to, those specified in any approved odour management plan, to prevent or where that is not practicable to minimise the odour.

Condition 1.3 Overarching Management Condition

Without prejudice to the other conditions of this Permit, the Operator shall implement and maintain a management system, organisational structure and allocate resources that are sufficient to achieve compliance with the limits and condition of this Permit.

On the 29 August 2017, Industry Regulation Officer Matthew Kelk during an investigation witnessed a strong odour along Glendale Avenue.

Site was attended and met with Neda Koleva and Peter Hallows.

It was established by Peter Hallows that the odour was from the Cat 2 Lorry arriving on site part laden with odorous waste from 2 Sisters Abattoir in Llangefni.

This was confirmed by a Part A notification received on the 29 August 2017.

Further Part B received 27 September 2017 - site are now bringing in empty trailers for CAT 2 waste following a review of collection arrangements.

Action

Ensure that procedures for CAT 2 waste are updated with the new collection arrangements by 15/03/2018. This will be audited at future inspections in 2018.

Breaches of permit conditions 2.2.6.3 and 1.3 , scored two category 3 scores.
