This compliance assessment report follows Natural Resources Wales substantiation of an odour complaint made by a member of the public (Earls Crescent) at approx 16:00 on 10th July 2013. The complaint was attended by myself and scald de-feather odour was detected outside the site boundary.

Offensive scald de-feather odour was noted on Chester Road outside site at 16:25 and 16:30 when passed on each occasion. A milder scald odour was detected at Earls Crescent.

The current absence of any abatement for scald de-feather odour is not BAT and continues to be in breach of permit condition 2.2.6. In accordance with Natural Resources Wales guidance this breach attracts a CCS score of 2. The score is suspended as an enforcement notice has been served requiring the equipment to be installed by 23/08/13. Providing the notice is met then this and any further CCS scores for similar breaches will not be applied nor affect your compliance rating / annual subsistence fees.
