Introductory note

This introductory note does not form a part of the notice.

The following notice gives notice of the variation and consolidation of an environmental permit.

This variation consolidates the permit and converts it to the modern permit format. It also incorporates an updated site plan.

The variation removes references to discharge consent (ref. CG0154003), which was revoked on 3 February 2009 as the regulations were superseded by the Environmental Permitting Regulations, and thereafter any discharges to water were covered by the current permit.

It also amends the monitoring requirements in the emissions to water table to reflect the change from the use of a chlorine-based disinfectant in the cooling tower waters, to a bromine-based product.

The schedules specify the changes made to the permit.
