Permit Section 2.8.1 accident management review to be carried out every 2 years; due 26/10/15, received 31.03.16. The accident management plan does not state how often it is reviewed. Section 1 refers to a quantitative risk ranking, however it is not clear how this ties to Table 1. Please tie the risk ranking to the process actions and resubmit the report by 30/06/16.

Permit Section 4.1.5 progress against environmental targets to be carried out every 5 years; due 31/12/15, received 31.03.16.

The above reports were all very late in being submitted and have been scored a compliance score of CCS4. Please review the EMS (environmental management system) to ensure procedures are in place to ensure the permit reports are submitted by the due dates.
