All emissions below permitted levels specified in permit VP3030BX.

Submission date for monitoring discussed with Managing Director via telephone. Some confusion by member of management staff (now left) that monitoring needed to be carried out at the end of each quarter, subsequently meant that submission of monitoring data by Befesa would be past submission deadline specified in permit. To reiterate our conversation that the extractive monitoring can be undertaken at any point during the quarter when the plant is operating under normal operating conditions.

Due to the above mitigating circumstances no score given for late submission on this occasion. Future late submissions will be scored.
