Data submitted for flare stack (A4) - low emissions of hydrogen sulphide shown from this point indicating effective abatement of this pollutant.

### Annual Returns

Annual data reviewed for waste disposal, water usage, energy usage and waste produced per tonne - no issues with submitted data.

### Revised Odour Management Plan and Fugitive Emissions Review

Detailed reports submitted for odour management plan and fugitive emissions review comparing operating techniques used on site against Best Available Techniques (BAT).

Additional actions for review identified for 2017 in the reports are:-

Installation of loading tunnels adjacent to the interim oxide storage (planning approved) subject to Capex and NRW approval.

Bubbler System and bubbler water return pump.

Review of interim oxide storage extraction pipework, extraction points and LEV capacity in this area.

Review of chemical plant LEV system capacity,

Non odour- review of ANVI plant in line with latest BAT.

It should be noted that permit variation EPR/VP3030BX/V004 using the new model permit template has removed the requirement to carry out a fugitive emissions report, this will not be required in future.

### Improvement Conditions

Improvement condition IC17 and IC18 still outstanding.

IC18 It is accepted that further work is being carried out to fully CCTV survey the required drains on site.

IC17 Waste classification of aluminium oxide still outstanding.

NRW require that the above improvement conditions are completed by 31st March 2017, non submission of reports required by these conditions beyond this deadline will be scored.
