4. Details of our assessment

On Friday the 19th of May 2022 waste regulation officer Boguslawa Pierzchala and Compliance Manager for Conwy and Denbighshire, Business Fire Safety attended at Lelo metal recycling Ltd. This was a planned unannounced visit following the incident that occurred on the 24th of March.

The officers met Gari Jones, site manager and TCM and Matt Bellis.

Accidents, emergency and incident planning

Fire Prevention and Mitigation Plan, FPMT, was discussed and it was agreed that this will be submitted to NRW by the 16th of July.

Fire procedures and staff awareness were discussed and checked and appeared in order.

Noise levels

At times, loads are being prepared before/after the opening times for the public. It was agreed with the management that efforts will be made to ensure the noise levels will be kept to a minimum.

There were no signs of fires taking place on site.

Storage of batteries

Batteries were seen in storage boxes which were kept outdoors awaiting collection on the day. Mr Jones showed the officer a metal container where batteries are normally kept.

Storage, handling labelling and Segregation

A number of cookers were seen on site which were not kept separate. Please see photo below. This has subsequently been scored against the below permit condition.

The site benefits from an S2 exemption which requires all waste accepted under its conditions to be kept separate and not treated on site.

Permit condition 2.3.2 Waste shall only be accepted if: (a) it is of a type and quantity listed in schedule 2 table S2.1
