4. Details of our assessment

On Thursday the 19th of May 2022 waste regulation officer Boguslawa Pierzchala attended at Lelo Aggregates. This was a planned unannounced visit.

This was the first visit after the permit was granted on the 13th of May.

Gari Jones, manager, accompanied officer throughout the inspection.

The site has been gradually cleared since the last visit to ensure enough space is available for the incoming waste.

At the far end of the site there were still some tyres left which had been left behind by a dissolved company- GMR. A good progress was noted with the removal of the tyres and Mr Jones stated the remaining quantity will be removed from site by the 16th of July as previously discussed.

Action: Please remove/dispose of the tyres currently stored in the far corner of the site by the **16th of July 2022**



A quantity of inert waste was seen on site. Mr Jones stated the majority of it had been generated on site by demolishing two buildings.



The site is secure with fencing, lockable gates and a 24/7 CCTV cameras in operation.
