4. Details of our assessment

The operator accepted waste on the 10th December 2021 which was coded as 17 05 04.

NRW informed the operator that the waste should have been coded EWC 13 05 01 * (Solids from chambers and oil / water separators).

13 05 01 * is an "absolute hazardous" and should not have been accepted on site because is in breach of the permit. Therefore a category C3 non compliance score has been applied.

Waste has now been removed on the 25th May 2022 and taken to another facility permitted to accept the waste. Thank you for the confirmation and documents in relation to the removal of the waste.
