Emissions to air

Monitoring of emissions to air via A1 was conducted on the 18/06/13 and 25/11/13. Monitoring data has been provided and shows compliance with Permit limits for both lead and particulates.

Performance Indicators

Performance indicators have been provided in accordance with Condition 4.13 for waste, water, lead usage, and electricity. Waste production is slightly higher than the previous year with the majority being recovered. Water consumption is down as is lead usage per tonne of product. Electricity is slightly more than the previous year.

Other deliverables

Fugitive emissions review provided in accordance with Condition 4.14.
Summary report of progress against EMS annual targets provided as required by Condition 4.15.
A review of substitution of lead stabilisers shows that they plan to be phased out by the end of 2014 (Condition 4.1.8).
The Operator is advised to continue to maintain the SPMP and associated documentation in preparation for Permit surrender.

Pollution Inventory Data has been submitted and OPRA review completed.
