The results of the monitoring were within the limits specified in the permit.

The following returns / reports were received by NRW on 28 April 2017.

*A1 (July - December 2016), E1 (2016), R1 (2016), PI1 (2016), Progress against targets report (2016), Substitution of lead stabilisers report 2016.*

The above were submitted before the end of April 2017, as requested in CAR NRW0027090.

The monitoring results supplied in A1 (July - December 2016) were the same results as included in A1 (January - June 2016), sampled on 21 July 2016. An e-mail received from Malcolm Brown (SES Coordinator) on 5 May 2017 confirmed that only one set of sampling was completed during 2016. It is understood that the operator stopped utilising lead in their process in October 2015, and have recently started the process of surrendering their Environmental Permit. Biannual sampling is still required at A1 until the surrender has been agreed by NRW, or the operator has sought written agreement from NRW for a minor operational change under condition 2.1.1 of the Permit (see condition 1.5).
