Permit condition 2.4.1 requires a waste minimisation audit to be carried out every 4 years, this was due in July 2015.

Permit condition 2.8.1 requires you review your accident management plan every 2 years, this was due July 2015.

Permit condition 4.1.2 requires that forms A1, R1, WU1, E1 and PI1 are submitted within 28 days of the end of the period, in this case 28 January 2016.

Permit condition 4.1.4 requires an annual review of fugitive emissions, a report detailing the findings should be submitted within 3 months of the end of the period.

Permit condition 4.1.5 requires the submission of a summary report on progress against the previous years targets by 31 January.

Permit condition 4.1.7 requires you to review your SPMP every two years, this was due in September 2015.

Permit condition 4.1.8 requires the submission of an annual report on the substitution of lead by 31 January.

The above late returns / reports have been consolidated and a CCS score of 4 awarded.

The results of the monitoring were within the limits specified in the permit.

The Operator should ensure that there are adequate procedures within their EMS to ensure that the reporting requirements of the permit are met.

Please submit the remaining outstanding returns by 30 September 2016 - namely A1 for Jan - June 2015 and Jan - Jun 2016 and fugitive emissions review.
