Beth Voice met with Brian Marson and Stewart Park from Farmers Boy.

The site have investigated whether Morrisons have a centralised environmental manager who would be able to help with environmental compliance. It was found that this role has been vacant for a couple of years. The Bradford site use Engreen as environmental consultants, and these are to be used for the Deeside site.

Requirement - Permit Section 4.2.2 and 4.2.3

Finding

The S1 returns for the monitoring results for July to December 2013 and W1, E1 and P1 for 2013 were submitted 9 months late for which the site has been scored in the previous CAR form. The reports were not completed correctly and need to be resubmitted. In addition, the reporting form S1 for January to June 2014 is outstanding, and was due to be submitted by 28/07/14.
