This Compliance Assessment Report follows a site inspection on 19/08/14 which specifically assessed site surface water drainage. This follows the detection of low concentrations of ammoniacal nitrogen in a discharge to surface water shared by Waen AD and local land / closed abattoir drainage.

Prior to the site inspection green dye was introduced into the septic tank serving the nearby property on Holywell Road. On the day of the inspection the discharge pipe to the water course serving the AD plant and closed abattoir was found to contain green dye which strongly suggests that the septic tank is the source of the ammoniacal nitrogen. No dye was present in the discharge the previous day. It appears likely, although not 100% certain, that there is an unmarked field drain carrying septic tank effluent to the section of pipe that runs between the AD plant and the water course.

During the inspection drains were lifted on the section of pipe line that carries surface water from the abattoir around the inside of the AD plant perimeter and down stream of the AD plant surface water storage tank discharge. No dye was present in this section of pipe and where tested with an in-situ test kit, ammoniacal nitrogen was 0.1mg/l or possibly 0 due to sample turbidity.

Approx 1 week prior to the inspection Biogen put green dye into the flare condensate knock out pot to assess any potential linkage to surface water drainage system. It is understood that the knock out pot chamber is constructed of concrete or brick (below ground level). Biogen found no linkage to surface water and dye remains in the knock out pot. As discussed during the site inspection it is recommended that the existing knock out pot is used as secondary containment by introducing an inner container. If this option is not pursued then Biogen must prove that the existing chamber is completely impervious to condensate and also subject to regular drain down and inspection. Please inform me of your intended actions by 12/09/14.

In summary, it appears highly likely that the source of ammoniacal nitrogen is the septic tank and not the AD plant or closed abattoir.

During the inspection a localised odour was noted from the biogas holder, but the exact source was not determined. As discussed please investigate the cause and options available to reduce odour from this source. Please inform me of your findings and intended actions (where appropriate) by 12/09/14. No odour was noted outside the site boundary during this inspection.
