1. Annual Point Source Emissions Monitoring

A monitoring report for emission point A1 (CHP exhaust) was received with an accompanying Part A notification for a significant breach of the sulphur dioxide emission limit (result 1132mg/m³, emission limit value 350mg/m³). All other parameters (NO_x, CO & VOC) compliant with emission limits. This is the first monitoring data obtained for the CHP since the plant was commissioned summer 2014.

The monitoring report is dated 28 January 2015 (monitoring completed 16/01/15) - Part A received within 24hrs of reporting.

This emission limit breach is a breach of permit condition 3.1.2 and attracts a CCS score of 3 (potential for minor environmental impact). Remedial action must be taken to secure permit compliance.

Biogen have reportedly taken measures to twice weekly monitor hydrogen sulphide concentrations in biogas and ferric dosing is being administered to reduce hydrogen sulphide concentrations in addition to routine servicing and maintenance of the CHP.

A Part B notification must be provided to Natural Resources Wales as soon as possible (ideally within 14 days of receipt of this report) detailing the root cause of the emission limit breach and action taken / to be taken to bring emissions into compliance. CHP emissions monitoring should be repeated (for selected parameters) at the earliest opportunity to demonstrate compliance once remedial measures have been taken.

Operational controls for biogas quality shall be determined by Biogen to ensure hydrogen sulphide concentrations in biogas do not cause a breach of CHP emission limit.

N.B No flare monitoring completed (emission point A2) as it operated <10% of the time (2%).

2. Annual Production / Performance Parameters

The plant has been operational since 23/06/14 - performance data reported for operational hours in 2014 as required. No issues noted.
