Progress with Improvement Conditions.

The only outstanding improvement condition prior to this visit was IC5B, which required a copy of the site EMS to be submitted for inspection. As the site has achieved Green Dragon Level 4 accreditation (July 2014) and is aspiring to meet Green Dragon Level 5 in the near future (ISO 14001 equivalent) this improvement condition is deemed to have been completed without submission of any EMS specific documentation. A review of the site's EMS may form part of a future Audit at the site.

Action: Please provide a copy of the Green Dragon Audit report (July 2014) for review.

Upgrade to internal extraction system & emission points.

A new extraction system is to be fitted to the product filling line due to demand for a repackaged product (Rubrik) that the site produces. The bulk ingredient is imported for repackaging from another installation within the Cheminova Group. The extraction system will allow staff on site to work in a more comfortable environment without the need for personal protective equipment. The system is to discharge via internal ducting and out through the old formulation plant room. Commissioning of this system will add a further emission point to the installation. It was noted during the inspection that emission point A0005 is now decommissioned and will not be used in future, changes to emission point A001 and A002 are also planned.

Action: A minor technical variation should be applied for to regularise the new emission point and include other minor changes that the installation has undergone since being permitted.

Herbicide Storage Area.

Works on the new bulk herbicide storage area were inspected. Civil Engineering contractors were finalising the installation of a concrete bunded area with integral drainage sump, which will house two new stainless steel storage tanks. All the works are being completed to the new CIRIA C736 guidance on Containment Systems for the prevention of pollution.
