Review of Q2 (April - June 2016) Monitoring data for Tata Shotton Landfill (submitted July 2016).

Whilst all external monitoring wells indicate gas within permitted limits, it is noted that leachate well L6 has started to show elevated levels of CO₂, marginal methane and depleted oxygen levels.

Maximum of 12.4% CO₂ and 1.9% Methane in April 2016 in leachate well L6. NRW require that L6 is closely monitored to ensure that landfill gas does not increase significantly in this well and these elevated gas levels are not detected in the external wells.

Three event moving average emission limit breach for Zinc borehole 10, May 2016. Minor breach of emission limit, it is unknown whether the zinc is from the operating landfill, as such no score awarded.

It is also noted that a recent Hydrogeological Risk Assessment (HRA) for the landfill has been submitted to NRW by Tata. The HRA has risk assessed the elevated Zinc using dilution adjusted trigger levels that shows no risk to the adjacent River Dee. The HRA has been accepted by NRW and as such the permit is likely to be varied to reflect these adjusted trigger levels.
