Assessment of landfill monitoring data for Tata Shotton, Q4 2016 (October 2016 – December 2016) and annual returns submitted under the annual reporting requirements of permit GP3030BE.

Q4 2016 Monitoring Data

Review of external well gas data submitted, elevated CO₂ above limit for BH1, BH8, BH9 and BH10 with a maximum of 2.3% . It is not known whether ground gas is from anthropogenic sources or from marsh/coal gas, as such no score given.

Elevated Methane and CO₂ noted within well L6 - Following recent site inspection and meeting with NRW, on going work is being undertaken by Tata to further characterise the gas regime on site.

Water Analysis - Moving point average Q4 2016 for Zinc elevated at a level 0.06mg/l above limit value of 0.02mg/l. Unknown source - no score given.

Following NRW agreement of HRA Tata due to submit variation to permit that will increase trigger levels, as such above value would not be a breach in future submissions.

Annual Returns 2016

Annual return documents reviewed - Tata review of monitoring results, energy, water and void space data submitted - no issues with data.
