Review of monitoring data submitted for Tata landfill to satisfy monitoring condition of permit number EPR/GP3030BE.

Exceeded permit emission limits:-

CO2 - external monitoring well in BH1 and BH 8 January & February 2016 and BH 8 March 2016.

Methane - external monitoring well BH8 - February 2016.

Zinc - BH10 - 3 point moving average.

Gas breaches possibly from non anthropogenic source - Tata in discussion with NRW over analysis of gas and whether source is from the surrounding marshes. Due to this no score has been given on the CAR form.

Zinc exceedance - source not entirely understood - following review of Hydrogeographical Risk Assessment (HRA) by NRW submitted by Tata late 2015, Tata are revising the HRA with the possibility of varying the permit in the near future, hence no score has been awarded for this breach.

Please note the above does not preclude NRW from scoring any future potential permit breaches if the source of gas and/ or zinc contamination is found to be from the regulated landfill.
